



BENEFITS “UPP”

In addition to mechanical protection, the “UPP” Program coverages offer the following benefits:

1. Nation-wide protection “UPP”

Ultra Protection Plan coverage is effective wherever you drive. Repairs can be performed by any authorized repair facility in the United States or Canada.

2. Transferable Protection

“UPP” coverage is transferable to a private party for a modest fee. This feature may substantially improve the resale value of your vehicle.

3. Car Rental

Reimbursement shall be made to the Customer for car rental expenses incurred due to a mechanical breakdown and/or failure covered under this Agreement. Prior approval must be obtained and valid receipts must be submitted for reimbursement. Benefits will be limited to the following schedules and must include an overnight repair. Reimbursement is \$30.00 per day to a maximum of \$150.00 per occurrence.

4. Towing

Reimbursement shall be made to the Customer up to a Maximum of \$50.00 per occurrence for towing expenses incurred due to a mechanical breakdown and/or failure covered in this Agreement. A valid towing receipt must be submitted for reimbursement.

5. Payment for Authorized Repairs

Administrator will make a payment directly to the repair facility so that you do not have to pay out of pocket and wait for reimbursement.
